You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type

The Sub-fund is part of INCOMETRIC FUND, organized under the laws of the Grand Duchy of Luxembourg as a mutual investment fund. This Fund is authorised and supervised in Luxembourg by the CSSF. The Depositary is Quintet Private Bank (Europe) S.A.

Term

The investment horizon is medium term and should be at least 5 years.

Objectives

The Sub-Fund is actively managed. The Investment Objective of the Sub-Fund is to achieve a total return via indirect investment in interest rates, dividends, and capital appreciation across the business cycle, understood as a time frame of 3-7 years.

Intended retail investor

Reserved for retail investors denominated in EUR. The investment strategy corresponds to investors with a high-risk tolerance and high investment risk profile. The fund will be targeting an annualized average volatility of 10-15% across the business cycle and on a 5-year rolling basis and will seek to stay within limits of 10-25% annual volatility.

What are the risks and what could I get in return?

The risk indicator assumes you keep the product for 5 years.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because the fund is not able to pay you.

We have classified this product as 4 out of 7, which is a medium risk class.

This rates the potential losses from future performance at a medium level, and poor market conditions could impact our capacity to pay you.

The stress scenario shows what you might get back in extreme market circumstances.

Unfavourable scenario: This type of scenario occurred for an investment between 31/12/2021 and 31/12/2022 (If you exit after 1 year), 30/12/2021 and 01/02/2024 (If you exit after 5 years).

Moderate scenario: This type of scenario occurred for an investment between 14/09/2015 and 14/09/2016 (If you exit after 1 year), 13/11/2015 and 13/11/2020 (If you exit after 5 years).

Favourable scenario: This type of scenario occurred for an investment between 11/04/2014 and 13/04/2015 (If you exit after 1 year), 04/11/2016 and 05/11/2021 (If you exit after 5 years).

What happens if Adepa Asset Management S.A. is unable to pay out?

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. We have assumed:

- In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

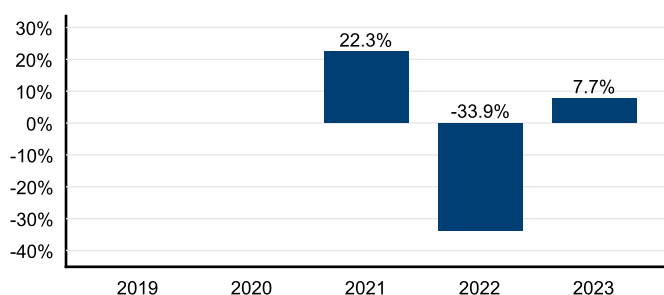
